TITLE I School Parent and Family Engagement

Bergenfield High School

Title I regulations require that each school served under Title I jointly develop with and distribute to parents of participating children, a written involvement policy agreed on by the parents that describes the requirements of SEC. 1118. C. POLICY INVOLVEMENT- Each school served under this part shall —

- (1) Convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved;
- Bergenfield High School will discuss its Title I program at its Open House general meeting on Tuesday, September 19, 2023, at 6:45pm. in the school auditorium. Parents whose children meet the criteria for the Title I programming will convene at a subsequent meeting at the end of Open House Night at 8:52 pm. also in the school auditorium.
- Parents who are unable to attend the scheduled Title 1 meeting are encouraged to contact the building principal and/or guidance counselor at any time with ideas, questions, suggestions and input. This can take place as a phone conference, email, personal meetings, or any other appropriate option.
- (2) Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under this part, including the planning, review, and improvement of the school parental involvement policy;
- Parent input regarding Title I program and services will be solicited during the Title I parent meeting.
- Parents of children who participate in the program are encouraged to contact the building principal and/or guidance counselor with any questions, concerns or suggestions they have regarding the Title I program and services at any time.
- (3) Provide parents of participating children
 - (A) timely information about programs under this part;
 - (B) a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet; and
 - (C) if requested by parents, opportunities for meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible;
- Information about Title I programs will be discussed at Fall Open House on September 19, 2023.
- Program and service overviews in relation to school test scores will be presented at the monthly Parents Association meetings
- Questions regarding new programs, suggestions and other information can be discussed when

requested by parents.

- (4) If the schoolwide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency.
- Parent input for the plan is shared at the Title I meeting and is relayed and taken into consideration in crafting the new plan.
- Parents submit written refusal to participate in Title I programming
- **D. SHARED RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT-** As a component of the school-level parental involvement policy, each school shall jointly develop with parents for all children served under this part a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement.
 - The parent compact will be made available on the district and school website

 - (2) Shall provide materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement.
 - Parents are provided with information on the Infinite Campus Parent Portal, Homeworknow.com and Google Classroom to utilize with their children to help achievement
 - (3) Shall educate teachers, pupil services personnel, principals, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school
 - Staff members are required to complete comprehensive grade reports, including progress reports, to accurately present student growth in a formal manner.
 - Parents will receive quarterly progress reports and report cards, and are encouraged to check student progress via the Infinite Campus Parent Portal
 - Teachers must reach out to parents of students who are struggling, via phone or email, to discuss or arrange, when needed, a parent conference; teachers shall respond to parent calls and emails in a timely fashion.

- (4) Shall, to the extent feasible and appropriate, coordinate and integrate parent involvement programs and activities such as parent resource centers, that encourage and support parents in more fully participating in the education of their children;
- Attendance at Title I parent meetings
- Attendance at school Parents Association meetings
- (5) Shall ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand;
- Information pertaining to Title 1 programs is posted on the school website Letters are mailed home related to program opportunities available to students Announcements of meetings and programs are available on the Infinite Campus Parents Portal
- (6) May involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training;
- (7) May provide necessary literacy training from funds received under this part if the local educational agency has exhausted all other reasonably available sources of funding for such training;
- (8) May pay reasonable and necessary expenses associated with local parental involvement activities, including transportation and child care costs, to enable parents to participate in school-related meetings and training sessions;
- (9) May train parents to enhance the involvement of other parents;
- (10) May arrange school meetings at a variety of times, or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize parental involvement and participation;
- (11) May adopt and implement model approaches to improving parental involvement;
- (12) May establish a districtwide parent advisory council to provide advice on all matters related to parental involvement in programs supported under this section;

- **F. ACCESSIBILITY** In carrying out the parental involvement requirements of this part, districts and schools, to the extent practicable, shall provide full opportunities for the participation of parents with children with limited English proficiency, parents with children with disabilities, and parents of migratory children, including providing information and school reports required in a format and, to the extent

practicable, in a language such parents can understand.
